







Minutes of the work of the committee for the selection of participants in the Advocacy Action at the ECCAR 2022 General Assembly on the "end climate change - start climate of change" project topics

On 31/08/2022, at 3.00 p.m., the members of the Commission of the above selection procedure shall meet, by means of telematic tools of collegial work through the use of the Google Meet platform, each at their respective homes or offices. The Commission is constituted as follows:

The Commission verifies that applicants meet the requirements of the call and that they have provided the required documentation. The prerequisites for admission to the assessment are:

- Be between 18 and 35 years of age (at the time of selection);
- Knowledge of the English language;
- Willingness to participate in the training meetings to be held between the beginning of September and the beginning of October (indicatively in the period between 12 September and 7 October);
- Willingness to participate in the ECCAR General Assembly to be held in Kadikoy (Istanbul) from 12 to 14 October 2022 and to prepare the Youth Delegation intervention;











 Sending CV and eventual self-declaration on the status as a Young Ambassador of the CoC project or the involvement in "End Climate Change - Start Climate of Change" project activities in any EU Member State.

Following this verification, the Commission notes that:

- the following applications are not admissible as they do not comply with the requirements: Adrien Croonen (under 18 years of age at the time of application);
- the following applications are not admissible as they did not submit the Curriculum Vitae necessary to complete the application: Geraci Valentina, Ghrissi Mariam, Тодоров Илия, Randeva Adriana, Colombo Mara
- the following applications are not admissible as authorisation to process personal data has not been given: Lughezzani Maddalena.

The Commission, having ascertained that a total of 33 applications are admissible, proceeds to evaluate the CVs and motivational letters of the applicants, on the basis of the criteria and scores indicated below.

Criteria	Maximum points
To be a Young Ambassador of the "End Climate Change - Start Climate of Change" project in any EU Member State.	10
Have already been actively involved in "End Climate Change - Start Climate of Change" project activities in any EU Member State.	5
Educational and/or work experience in the field of the issues covered by the project: climate change, environmental justice, migration, colonialism, anti-racism.	20
Personal, academic and/or professional motivations.	20
Total	55 Points

On the basis of the above evaluation grid, points were awarded to applicants and, consequently, a ranking was drawn up for them (Annex 1). It should be noted that, in awarding the points, the completeness and level of detail of the information presented in the CVs was considered as an element of added value. For those candidates who indicated in their application form that they are Young Ambassadors of the CoC project (10 points) and that they had taken part in CoC project activities (5 points), it was decided to consider 10 points in total. Furthermore, taking into account the specificities of the ECCAR event and based on the characteristics of the applications received, an attempt was made to maintain a balance of gender (4 females and 2 males) and of origin (3 from Italy and 3 from other countries) among the participants, valuing the candidates' commitment to activities at local/city level, an important aspect in the ECCAR context. It was also decided to dedicate two of the six available places to candidates who have not yet had experience with the CoC project but who have nevertheless gained experience with the topics covered by the project and have strong motivation to participate.











Following the evaluation phase, the Commission decided to admit to the project the first 6 applicants with the highest score:
